Members of the Delaware Advisory Council on Career and Technical Education are given the responsibility, by State Law, to monitor and evaluate career and technical education programs in Delaware. The purpose of program monitoring is to bring about program improvement for our CTE students. During monitoring visits, a DACCTE staff and Council member are joined by a CTE Education Associate from DOE when possible. The team visits schools to gather information on career and technical education programs so that constructive program improvement recommendations can be formulated and communicated to those who implement the programs.

School monitoring visits typically take place between September and June on a two-year rotation of schools. DACCTE members, as advocates for career and technical education, approach each monitoring visit with an open mind. Our role is to provide an unbiased perspective to help educators. Specifically, Council members use a monitoring questionnaire provided by Council staff as an interview guide when talking with school personnel. After conducting all the interviews, DACCTE Staff analyze all questionnaires and information gathered during the visit. After analysis of all available data, recommendations for program improvement are formulated and communicated to the appropriate agencies, organizations, and individuals. The results of the William Penn HS CTE program visit are as follows:

12 teachers were interviewed, and 22 surveys were completed. 33 unduplicated contacts.

They report that the programs are following Course Pathways/Program of Studies, Career and Technical Student Organizations are available, Advisory Committees are happening, demographics of the classroom represent the demographics of the school, and teachers are reflective of individual program strengths, weaknesses, and needs for improvement. Mr. Saunders (Principal) and Mr. Talmo (Assistant Principal) are very supportive of all CTE programs.

## Recommendations

- Funding Teachers are all receiving Perkins and 509 funds. All teachers are receiving needed
  materials and supplies. Please share funding levels, etc. with all stakeholders to assist with
  daily/long term planning processes.
- Work-Based Learning- Strong WBL program in place and working to meet all program needs across the entire CTE department. Continue to support this position.
- WBL Opportunities- The culinary program runs a Cafe for teachers, administrators, etc. to
  participate with meals on certain days of the week and the integration of the Penn Farm to the
  Culinary and Agriculture programs allows the students to gain real world experiences and put
  classroom learning into action. This is not to take away from the other great opportunities
  occurring in WBL at WP HS, this is highlighting two of the many.
